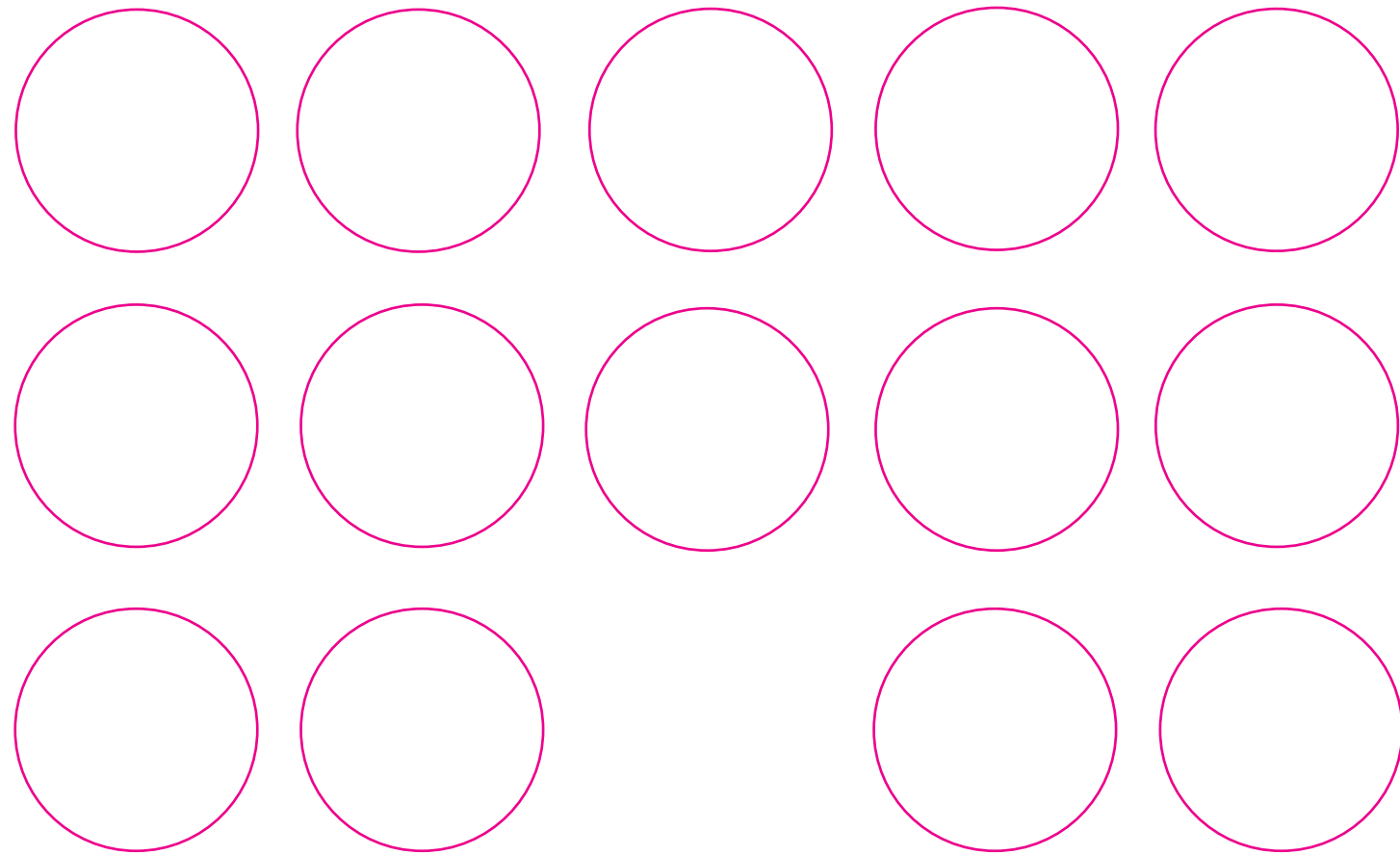

## ASSOCIATE OF THE AMERICAN COLLEGE OF CARDIOLOGY:

For those who qualify, the Associate of the American College of Cardiology (A.A.C.C.) designation signals a commitment to the highest standards of cardiovascular care. To become an A.A.C.C., one must complete a national board certification in an area of cardiovascular expertise, continue their education in the field of CV medicine, and demonstrate a commitment to their professional development.

### The full list of applicant criteria is as follows:

1. Hold a current and valid state license
2. Hold a nationally recognized board certification
3. Demonstrate that the majority of professional activities are devoted to the field of cardiovascular disease
4. Provide three sponsorship letters from current F.A.C.C. members
5. Be employed in a practice that is primarily focused on CV care
6. Demonstrate commitment to CV practice for five years or more
7. Be a CCA member of the ACC for two years prior to applying for designation
8. Obtain at least 12 hours of CV related CE credit hours annually
9. Be a current member of the ACC's Cardiovascular Team Section



## HOW TO BECOME AN A.A.C.C.?

1. Complete the A.A.C.C. application form.
2. Obtain and attach three letters of recommendation from current F.A.C.C. members.
3. Provide a copy of current license, proof of board certification and CE activities for the last calendar year.
4. Payment of \$25 application fee (credit card or check payable to the American College of Cardiology).

### Credentialing Bodies for the Associate of the American College of Cardiology (A.A.C.C.)

The following credentialing bodies are deemed acceptable for the Associate of the American College of Cardiology (A.A.C.C.) designation. Each of the following credentialing bodies provides board examinations that are nationally recognized.

#### I. Accreditation Council for Clinical Lipidology (ACCL)

(<http://www.lipidspecialist.org>) is an independent certifying organization that has developed standards and an examination in the field of Clinical Lipidology for the growing number of allied health professionals who manage and treat patients with lipid and other related disorders.

#### II. American Association of Critical-Care Nurses (AACN)

(<http://www.aacn.org>) AACN is the largest specialty nursing organization in the world, representing the interests of more than 500,000 nurses who are charged with the responsibility of caring for acutely and critically ill patients. The association is dedicated to providing our members with the knowledge and resources necessary to provide optimal care to critically ill patients. AACN Certification Corporation administers certification and renewal programs for nurses to proudly demonstrate the specialized knowledge, skills and abilities necessary for safe and effective acute and critical care nursing practice. A mark of excellence, certification contributes to improved patient health and safety by establishing and promoting high standards of professional practice. AACN Certification Corporation specialty exams, CCRN, CCNS and PCCN, as well as the subspecialty exams, CMC and CSC, have all been accredited by the National Commission for Certifying Agencies (NCCA), the accreditation arm of the National Organization for Competency Assurance (NOCA).

#### III. American Nurses Credentialing Center (ANCC)

(<http://www.nursecredentialing.org>). A subsidiary of the American Nurses Association, ANCC provides individuals and organizations throughout the nursing profession with internationally renowned credentialing programs that certify nurses in specialty practice areas, recognize healthcare organizations for nursing excellence through the Magnet Recognition Program®, and accredit providers of continuing nursing education. ANCC is the largest and most prestigious nurse credentialing organization in the world, providing certification exams to validate nurses' skills, knowledge, and abilities. More than a quarter million nurses have been certified by ANCC since 1990, including more than 75,000 advanced practice nurses. ANCC offers nursing certification in 26 different specialties, including CCRN for critical care, CCNS for clinical nurse specialists, PCCN for progressive care nurses; ACNPC certification for acute care nurse practitioners, CNML certification for nurse managers and leaders; and two subspecialty certifications in cardiac medicine (CMC) and cardiac surgery (CSC). ANCC's exams are accredited by the American Board of Nursing Specialties and the National Commission for Certifying Agencies.

#### IV. American Academy of Nurse Practitioners (AANP)

(<http://aanpcertification.org>). The purpose of the American Academy of Nurse Practitioners National Certification Program is to provide a valid and reliable program for entry-level nurse practitioners to recognize their education, knowledge and professional expertise. The National Certification Program provides a process for validation of an advanced practice nurse's qualifications and knowledge for practice as a nurse practitioner. The National Certification Program was established as a certification body for the evaluation of individuals who wish to enter, continue and/or advance in the profession through the certification process. The certification program is an independent incorporated non-profit organization.



**V. Board of Pharmaceutical Specialties (BPS)**

(<http://www.bpsweb.org/>) is a certifying body that provides certification for clinical pharmacists. Board certification through BPS—the Board of Pharmaceutical Specialties—is key to fostering pharmacists’ inevitable evolution from order-filling agents to integral members of the patient care team. The Joint Commission of Pharmacy Practitioners (JCPP) predicts that, by the year 2015, pharmacists “...will be the patient care providers that healthcare systems and payers recognize as being responsible for ensuring desired medication use outcomes.”

**VI. National Commission on Certification of Physician Assistants (NCCPA)**

(<http://www.nccpa.net>) is the only credentialing organization for physician assistants in the United States. Established as a not-for-profit organization in 1975, NCCPA is dedicated to assuring the public that certified physician assistants meet established standards of knowledge and clinical skills upon entry into practice and throughout their careers. Every U.S. state, the District of Columbia and the U.S. territories have decided to rely on NCCPA certification as one of the criteria for licensure or regulation of physician assistants. Approximately 60,000 physician assistants have been certified by NCCPA.

**VII. NASPE (now Heart Rhythm Society)**

(<http://www.ibhre.org>) created a wholly owned subsidiary, NASPExAM®, to develop and administer an “Examination of Special Competency in Cardiac Pacing and Cardioversion Defibrillation” for the physician. The examination was first offered in 1986. At the request of non-physician Allied Professionals, i.e., engineers, technicians, physician assistants, and nurses employed by hospitals, in academe or by industry, an “Examination of Special Competency in Cardiac Pacing and Cardioversion Defibrillation” for the Allied Professional, NASPExAM® AP/Pacing, was developed and initially administered in 1989 after being administered on a trial basis to a select group of examinees in 1988. This examination was administered in 1989, 1990, 1992, 1994, 1996, 1998, 2000, 2001, and 2003 and is now offered biennially during the Annual Scientific Sessions.

**VIII. Pediatric Nursing Certification Board (PNCB)**

(<http://www.pncb.org>) gives national examinations for pediatric nurses and nurse practitioners that are the only certification exams collaboratively designed by CPNPs®, CPNs®, and pediatricians. PNCB exams are recognized and endorsed by the American Academy of Pediatrics (AAP), the Society of Pediatric Nurses (SPN), the Association of Faculties of Pediatric Nurse Practitioners (AFPNP) and the National Association of Pediatric Nurse Practitioners (NAPNP). All PNCB certification programs are accredited by the National Commission for Certifying Agencies (NCCA).
